## HTF Funds Affordable Group Homes for Persons with Special Needs

In 2018 the Housing Trust Fund funded two special needs group homes sponsored by the Tri-Counties Community Housing Corporation. The first permanent loan of \$483,000 assisted Tri-Counties CHC in acquiring and renovating a single-family home in Solvang that will provide permanent housing and 24-hour services for medically frail persons with developmental disabilities. The second loan of \$505,000 helped the agency acquire another group home in the rural area of Lompoc where persons with developmental disabilities will receive comprehensive services and supports which will allow them the opportunity to reside in our community near their families and friends. The Housing Trust Fund is pleased to partner with Tri-Counties CHC to provide the permanent financing for housing for residents who would otherwise have to continue to live in skilled nursing facilities or the state run developmental centers.
